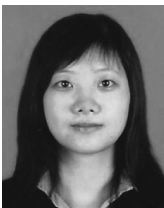


## AUTHOR PROFILES

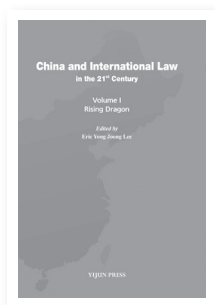

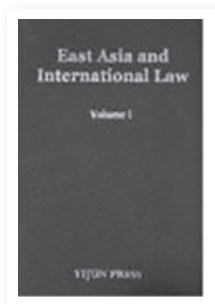
