# **GRANDVIEW INSTITUTION**





## 1. Introduction

The Grandview Institution was founded by Mr. REN Libo (President), former chief correspondent of Xinhua News Agency in Pyongyang. In 2013, Chairman Xi Jinping first proposed the goal of building a "new type of think tank with Chinese characteristics." This is the clearest and richest instruction on the construction of think tanks ever given by a top central leader. The momentum of Chinese think tanks has thus been "bursting forth." In May of that year, the Grandview Institution was born at last.

In recent years, it has become popular in China to run think tanks in all sectors of the society with higher expectations, hoping that they can play a greater role in social reforms and progress. In this regard, China's private think tanks try to come up with significant results responding to the requirements of the new era and new tasks. The Grandview Institution believes that think tanks must first of all have a rigorous data accumulation as research base and carry out policy research out of political discussion, so that they must not "feel something" and boast about it. Secondly, a new type of think tank with Chinese characteristics must be developed for promoting decision-making system, optimizing decision-making process, and improving the quality of decision-making. In addition, excellent researchers should be familiar with the decision-making process with preferable experience. Decision-making should not be detached from the actual operation.

There are various types of think tanks in China, such as media-based think tanks and public relations think tanks, but the atmosphere of domestic think tanks in China is actually not very favorable. "Research" is a long-term process that requires careful cultivation and sustainable growth. Influencing policy-making is not a drum beating, but treading on thin ice with a pragmatic and rigorous attitude.

The Grandview Institution believes that in the era of globalization, national think tanks have influence not only on domestic, but also on foreign governments to some extent. As the exchange between Chinese and foreign think tanks is increasing in a relevant and strategic manner, both are recommended to listen to

each other's views and opinions, promote mutual understanding and trust, and systemize their respective national decision-making systems.

# 2. Development

Founded in 2013, the Grandview Institution has become one of the leading private independent think tanks in China. In accordance with the China Think Tank Index (CTTI)'s Think Tank Report released in 2018, the Grandview Institution was ranked 6th on the list of China's Social Think Tanks Rating.<sup>2</sup> Other social think tanks on the list include Pangoal Institution, Center for China and Globalization and other well-known think tanks in China. CTTI is jointly developed by the China Think Tank Research and Evaluation Center of Nanjing University and the Think Tank Research and Publication Center of Guangming Daily. For the past years, the authority and objectivity of the CTTI Think Tank Report have been widely recognized by the industry with a high reference value. In addition, the Grandview Institution is the only private and civil think tank in terms of reporting to the central government's decision-making internal reference.

# 3. People



REN Libo (President), born in 1979, graduated from Shandong University with a bachelor's degree in international politics and is currently an EMBA student in Tsinghua University. Before founding the Grandview Institution, Mr. Ren had been working for the Xinhua News Agency for 10 years. In his previous decade-long service to Xinhua News Agency, Libo has been

leading various divisions, including the Cankao Xiaoxi, the Xinhua Pyongyang Bureau, the Reference News Department, and the CNC. From 2001 to 2011, he was appointed to draft special reports to CPC Central Committee and the State Council. Also, he has conducted a large amount of in-depth field research and reports on significant political and economic issues, therein his suggestions and work were highly appreciated and have influenced the decision-makers.



TIAN Shichen (Vice-President) was born in 1975, went to the University of Foreign Languages (A.B. in English), PLA, Luoyang, Xi'an Politics Academy (LL.M.), People's Liberation Army (PLA) / University of Nottingham, UK, and Wuhan University (PhD in Public International Law). He was former Director of the Crisis Management Affairs and Media Division

of the Information Office of the Ministry of Defense, Deputy Chief of Staff of the Eurasian Bureau of the Office of International Military Cooperation of the Ministry of Defense. Here, Dr. TIAN was responsible for the crisis management and media coverage of major military operations and incident involving foreign militaries, and the direction of Europe and Central Asia Policy research and planning for international military cooperation. Dr. TIAN has worked in different positions in grass-roots field forces, academic institutions, headquarters, and military commissions. He has long been engaged in military diplomacy, journalism, and legal services. He is committed to the daily liaison and coordination of the office of the foreign-related response mechanism of the entire army. He communicated with foreign government agencies and media organizations and participated in major bilateral and multilateral negotiations with more than 30 countries.





LIU Wendou (Co-chair of Board of Trustee) was born in 1967, got his Bachelor of Russian Language and Literature at Peking University and Doctor of Russian Language and Literature at Voronez State University, former Soviet Union. As a colonel (retired), he was former Commissioner of the International Military Cooperation Office of the Central Military Commission,

National Defense Attaché of the Chinese Embassy in Georgia, Deputy Military Attachment of the Chinese Armed Forces of Russia's Land, Sea, and Air Forces, Deputy Director of the US Department of Foreign Affairs of the Ministry of National Defense, and Director of the Central Asia Division of the Eurasian Bureau. Dr. LIU has rich experience in military diplomacy. He has visited dozens of countries as a member of the high-level military delegation of the Chinese People's Liberation Army. He has participated in the planning and implementation of major diplomatic activities such as the Shanghai Cooperation Organization Defense Ministers Meeting and large-scale joint exercises between China and foreign countries.

#### 4. Vision & Focus

The Grandview Institution's philosophy is that mutual understanding in the international community is the key to promoting efficient and effective global governance. Therefore, while objective, forward-looking, in-depth, and practical researches are fundamental to the Grandview's development as an independent think tank, people-to-people exchanges are also indispensable. In the spirit of pragmatism, the Grandview has gradually established a global network of research fellows and think tanks respectively regularly hosting small-scale and in-depth discussions, debates and joint research projects. To achieve the best possible outcomes in contributing to the efficiency and effectiveness in global governance, the Grandview has decided to invest its very best resources in the following areas of studies: Global Maritime Governance, International Law of Military Operations on the Sea, Belt and Road Initiative, Borderland Governance, Sino-U.S. Relations, Sino-European Relations, the Korean Peninsula, and Russia & Central Asia.



## 5. Governance

The Grandview Institution is independent in three aspects. First, we are free from government budget. Second, we set our research agenda independently. Third, we hire our people independently. As the Grandview is a private think tank, our funds are from the following: 1. Contract-based research project from enterprises such as Alibaba and Byte Dance. We also have some contacts with European enterprises. 2. Contract-based research projects for local and central government agencies and department; 3. Charitable donation from private companies and individuals. We influence policy-makers through following channels. First, we do contract-

We influence policy-makers through following channels. First, we do contract-based studies for local and central government departments and agencies such as the Ministry of Foreign Affairs, the Ministry of National Defense, the Committee of Development and Reform, etc. Second, some of our research fellows are advisors for local and central government. Third, some of our research fellows are retired civil servants or military officers, who, to some extent, still have affiliation with government. Through the above-mentioned channels, we have produced independent research projects, periodicals, data analysis for research support and policy recommendations to various government agencies.

#### 6. Networks

So far, by adopting interdisciplinary approaches and actionable data, the network of over a hundred renowned scholars, government officials, senior journalists, and business leaders has produced independent research projects, periodicals, and data analysis. In addition, we have provided highly recognized research support and policy recommendations to China's Central Government agencies such as the Ministry of Foreign Affairs, the Development and Reform Commission, the Ministry of Commerce. The Grandview's clients also include private sectors and local governments of Beijing, Chongqing, Guangdong Province, Guangxi Province, Fujian Province, and Jiangsu Province among others, whose development planning and industrial development have benefited from our studies. As we further expand the two global networks that connect all those relevant with one another, more international dialogues will take place in addition to our six existing dialogue series: China-US Relations, China-Europe Relations, China-



NEA Relations, Grandview-ASEAN Think Tanks, Global Maritime Governance, and BRI Country Cooperation and Development. In 2020, due to the breakout of COVID-19 pandemic, the Grandview Institution kept bridging think tanks via online and scholars all over the world and organized over 40 bilateral dialogues on regional security, trade environment, and bilateral relationship.

Other cooperating partner think tanks of the Grandview include the Carter Center, the Korean Foundation, the Konrad Adeneur Stiftung, the China Academy of Social Science, the Development Research Center of Chinese State Council, the China Institute of Contemporary International Relations, etc.

#### 7. Recent Events

In 2020, due to the impact of the COVID-19 pandemic, all the events of the Grandview Institution were held online. The Grandview hosted more than 30 online dialogues with scholars and practitioners of international relations from the United States, Japan, South Korea, and Germany covering such topics as bilateral political relations, economic and trade exchanges, cooperation on preventing epidemic, and the security situation around China. The dialogue provided not only a platform for experts from both sides to maintain mutual understanding and communication, but also a flexible and unique perspective on how to understand the international challenges and risks under the pandemic.
